1. Spencerport Canal Days Committee will assign a specific location from which the Exhibitor may operate during the 2026 Spencerport Canal Days Event, July 25<sup>th</sup> and 26<sup>th</sup>, 2026.
2. Exhibitor will have display staffed and open 10:00 am – 5 pm, Saturday, July 25 and Sunday, July 26, 2026. Set up time to be determined.
3. Exhibitor will supply its own signage at its assigned location. Exhibitor, at its assigned location, may promote (please fill information in below):

4. Only one business or organization may operate in Exhibitor's assigned location. Sharing of this space with other businesses or organizations, whether related or not, is prohibited.
5. Exhibitor personnel will follow the Spencerport Canal Days policies and procedures.
6. Exhibitor will have sufficient personnel staffing the location during operating hours.
7. Exhibitors will be listed as a festival exhibitor in all printed material that includes such listings.
8. Exhibitor agrees to file with Spencerport Canal Days, no later than June 14, 2026, a Certificate of Insurance listing Spencerport Canal Days as additional insured, with proof of the following coverage:
  - a. General liability in minimum limits of \$1,000,000
  - b. Products liability in minimum limits of \$1,000,000
  - c. Workers' Compensation in accordance with the laws of New York State
  - d. Automobile liability in minimum limits of \$1,000,000
9. Failure to provide the Certificate of Insurance shall terminate this contract.
10. Exhibitor agrees to defend and indemnify Spencerport Canal Days Committee and their agents and employees, against any and all losses, expenses, claim, suits, damages, or causes of action whatsoever arising out of the granting of this contract; and against any order of decrees or judgments which may be entered therein, due to any injury to any person and/or property or loss of life sustained in or about the Spencerport Canal Days Festival and buildings, tents, and improvements thereon, or associated with the event during the term of this contract.
11. This contract is exclusively between the Spencerport Canal Days Committee and the exhibitor for the 2026 Spencerport Canal Days Festival. This contract does not provide the exhibitor with any claims, warrants, or other rights against the Canal Days Committee.

12. Spencerport Canal Days is not responsible for tent rentals. The exhibitor must provide his or her own tent for use during the festival.
13. Exhibit size: 10' x 10' (\$450.00) or 10' x 20' (\$850.00)
